



APEX[™] Coloured Cast Acrylic 10 year warranty (International)

APEX guarantees that APEX™ Colored Cast Acrylic Sheet for exterior applications will comply with the performance specifications listed by APEX in the information below for a period of ten years, subject to the following conditions:

- 1. The warranty period of ten years commences from the date of delivery of the APEX™ colored product to the end customer relating to the warranty.
- 2. The warranty relates to the UV transmission of the sheet as delivered and in particular:
 - The sheet must be appropriately stored and transported prior to fabrication and installation (Manufacturer's suggestions are available on request).
 - An acceptable standard of workmanship (according to APEX's suggestions) shall be used in fabrication
 and installation. APEX will not be liable for any failure attributable to any breach of these standards.
 - The warranty does not cover any failure attributable to causes not associated with the normal and suggested use of APEXTM acrylic sheet. It does not apply to harm and deterioration caused by the incorrect use of chemical agents, cleaning fluids, unsuitable sealants, or decorative materials.
- 3. APEX must be provided with immediate advice of any potential claim. Enough evidence of any potential claim must be provided to APEX, and APEX or its authorized representatives must be allowed adequate facilities to substantiate the claim.
- 4. If any APEX™ acrylic sheet does not meet APEX's satisfaction as complying with the manufacturer's performance specifications within the 10-year stipulated period, APEX will replace the deemed non-compliant sheet on an ex-works basis with an equivalent quantity of APEX™ acrylic sheet. APEX shall under no circumstances be responsible for any other damage or loss, howsoever arising, whether directly or indirectly.
- 5. APEX provides no warranty, guarantee, or implied statement/advice in relation to APEX $^{\text{TM}}$ acrylic sheet apart from the guarantee given herein.
- 6. This warranty and all the terms thereof shall apply to all deliveries of APEX™ acrylic sheet supplied by APEX until the guarantee is revoked by either party:
 - Revocation may be provided by either party serving notice in writing to the other.
 - Revocation shall not affect deliveries of APEX™ acrylic sheet made prior to the date of revocation, which shall continue under the full terms of this guarantee.
 - UV performance values at the time of manufacture of the Substrate Material are available from your supplier or on request from APEX, provided you can quote the APEX™ lot or serial number for your Substrate Material.
- 7. If the customer brings any claim under this warranty, it must produce documentary evidence to APEX's satisfaction that the sheet in question is without any doubt APEXTM acrylic sheet produced solely by APEX:
 - The claimant must present the commercial invoice/proof of purchase from the seller listing the name and address of the user, date of purchase, full product type/name, and the product quantity purchased.
 - APEX must, within a reasonable period, be permitted to inspect the claimed defect and its potential causes on-site or have an appointed third party inspect on APEX's behalf.
- 8. This warranty document relates to external applications further processed/fabricated from APEXTM acrylic sheet.

APPENDIX

Outdoor Aging and Weathering Behavior of APEX™ Cast Acrylic Sheet for External Applications:

- During the Warranty Period, the modulus of elasticity of the Product will not reduce by more than 30% from the value recorded at the time of manufacture (ref. APEX™ Technical Properties).
- During the Warranty Period, the flexural strength of the Product will not reduce by more than 30% from the value recorded at the time of manufacture (ref. APEX™ Technical Properties).

COLOR FASTNESS

During a ten-year outdoor exposure period, all colored APEXTM acrylic sheet surfaces can be expected to exhibit at least some degree of change. APEX guarantees that any changes in the color of the APEXTM acrylic sheet will be minor and insignificant, relative to the exposed APEXTM acrylic sheet.

ANALYSIS

Any warranty-specified values will be determined using cleaned specimen samples. For finished complex structures, the measured values are determined on flat samples only. Otherwise, the APEX™ acrylic sheet values cannot be determined to the required level.

GOVERNING LAW

All warranty claims shall exclusively be determined and governed by the version of this warranty statement valid on the date of purchase of the APEXTM acrylic sheet being claimed. All warranty disputes shall be exclusively resolved according to the governing laws of South Africa, without giving effect to conflict-of-laws principles. This warranty does not affect or restrict any rights or claims specifically available to consumers under applicable law. The exclusive place of authority for any rights or claims from this warranty shall be Kempton Park, South Africa.
