

Limited Product Warranty

10 YEARS LIMITED WARRANTY

POLYCARBONATE SHEETS - TUFFAK 2UV

Warranty

Plaskolite ("Plaskolite Israel Ltd.", "Plaskolite Bulgaria Ltd.") warrants the following properties of Polycarbonate plastic sheet Tuffak 2UV ("the "product") for a period of 10 years from the date of purchasing ("The Warranty Period") according to the conditions of the warranty:

- » Light Transmission, when measured in accordance with ASTM D1003 - 07 (Procedure A, illuminant C), will not undergo more than 6 Light Transmission % units from its original value.
- » Modulus of Elasticity, when measured in accordance with the procedure specified in ISO 527-2, will not undergo 2100 MPa.
- » Tensile Strength, when measured in accordance with the procedure specified in ISO 527-2, will not undergo 55 MPa.

All values shall be measured on cleaned and polished specimens conditioned in a standardized climate 23°C/50% RH until equilibrium is reached.

This warranty is given only to sheets which are transported, stocked, installed, used, cleaned, and maintained in accordance with Plaskolite technical specifications and guidelines, and which have not been vacuum formed or thermally molded, formed, painted, coated or exposed to harmful chemical influences.

No warranty will be available for sheets that have been exposed to non-compatible materials and environments. This warranty does not cover a finished article manufactured by the customer from Tuffak 2UV sheets.

If the product fails to conform to this warranty, the purchaser may, within the warranty period, and no later than thirty (30) days following discovery of the failure to conform to this warranty, send written notice of the failure to conform to this warranty along with proof of purchase to Plaskolite.

Upon receipt of the written notice, Plaskolite will, at its sole option, replace that portion of the product that failed to conform to this warranty or refund the purchase price of that portion of the product that failed to conform to this warranty.

Plaskolite will not be responsible for any costs of removing any portion of the product that failed to conform to this warranty or of reinstalling the replacement. Replacement or refund as described herein is the purchaser's sole and exclusive solution for failure of any part of the product to conform to this warranty, or any warranty which may arise by contract or operation of law. Repair or replacement of any part of the product that failed to conform to this warranty does not extend the warranty period.

Plaskolite's liability is limited solely and exclusively to repair or replacement as set forth herein and does not include any liability whatsoever for any incidental, consequential, or other damages of any kind whatsoever, whether a claim is based upon a theory of contract, negligence, or breach. This warranty is made only to the purchaser and is not transferable.
